CORRESPONDENCE – A letter was received from Laura York requesting the Township allow her to ride the North Kent Transit service bus to work although she lives in Ionia County. After discussion, the Board was not in support of this request.

COMMUNITY DEVELOPMENT CONTRACTS – Hope Network’s contract was submitted for approval. The amount allocated from Community Development funds for the North Kent Transit Service for the 2008/2009 year is \$2,445.00. Thompson moved, Stougaard seconded, to authorize the Supervisor and Clerk to sign the contract. Motion carried. Senior Neighbors contract was also submitted for approval. The amount

allocated for Senior Neighbors is \$4,482.00. Thompson moved, Bonn seconded, to authorize the Supervisor to sign the contract. Motion carried.

ADJOURNMENT – Bonn moved, Stougaard seconded, the meeting adjourn at 7:25 p.m. Motion carried.
